Why at Trident Park, Mriehel?

Situated opposite the historic 17th Century Wignacourt Aqueduct in the Central Business District, Trident Park consists of seven low-density and low-rise, terraced office buildings, all of which are intersected by gardens, courtyards and terraces, taking inspiration from typical Maltese palazzos and their central courtyard, all whilst remaining sensitive to the architectural importance of the iconic landmark colonnade, part of the original façade of the Farsons Brewery.



The campus was designed and built to meet the strictest of environmental codes and introduces state-of-theart environmental technologies, including those for the cooling and heating of the buildings, with an emphasis natural lighting and ventilation, while minimising the environmental footprint to create a genuine and vibrant green office campus and world-class business destination. It offers flexible office spaces complemented by eateries, a gym, medical services and a child-care centre.

The main entrance to the Farsons Brewery and the original boardroom were carefully restored and the structure extended to further accommodate a conference hall catering for up to 170 persons. Trident Park is honoured to host MACM as its first patrons of its newly opened conference facilities.

Mr Charles Xuereb

Charles is Chief Executive Officer of Trident Estates plc. Since 2017 and is responsible for the group's property interests.

Charles started his professional career with PricewaterhouseCoopers. He joined Simonds Farsons Cisk plc ("SFC") in 1995 as Chief Accountant of Food Chain Group and between 2005 and 2017 served as the Chief Financial Officer of SFC, being responsible for the Group's overall financial management, direction and governance as well as the Group's Credit Control, Information Technology and Business Services. He was a member of the Group Executive Board and sat on the board of a number of companies.



Charles is a Certified Public Accountant, a Fellow of the Malta Institute of Accountants, a member of the Malta Institute of Management and was elected President of the Malta Association of Credit Management in 2013, a position he still holds to date.



Mr Giovanni Bartolotta

Giovanni joined APS Bank as Chief Risk Officer in September 2018. Prior to joining the Bank, he spent 10 years in London working for major global investment banks, including Kleinwort Benson, JP Morgan Chase & Co. and Bear Stearns International. He then moved to Malta where he spent fourteen years at FIMBank p.l.c., as Executive Vice President and Global Head of Risk. Mr. Bartolotta holds a B.A. in Economics from Bocconi University of Milan.





Dr Kevan Azzopardi

Dr Kevan Azzopardi has been appointed as Official Receiver in February 2012. In his role, Dr Azzopardi practices in the field of restructuring, dissolution and winding up of companies by the Court on cases which often involve cross-border elements. He is a member of the Executive Committee of the Malta Business Registry.

Dr Azzopardi is lead in a team of experts appointed by the Ministry for Justice, Culture & Local Government, in the area of Insolvency Law dealing with Government Policy and the reform of insolvency and commercial matters, as well as implementation of European Union Directives which in turn lead to the enactment in December 2022 of three important Acts in the field of insolvency and bankruptcy law. He has chaired the Working Party on Civil Law Matters, on insolvency, restructuring and second chance during the Maltese Presidency of the Council of the European Union, for the launch and negotiation of the proposed Insolvency Directive in January 2017. Dr Azzopardi is involved as an expert on insolvency and represents Malta in the UNCITRAL Working Group IV since 2016. He is a regular speaker in these areas both locally and internationally.

Prior to his involvement in the area of insolvency, he held office as Eurojust National Correspondent for a two year period since August 2006, promoting judicial cooperation between European Union Member States in criminal matters under the European Judicial Network. He was a Member of the Refugee Appeals Board appointed in terms of the Refugees Act, Cap 420 of the Laws of Malta, between 2013 and 2019.

A law graduate of the University of Malta, Dr Azzopardi has been a visiting lecturer thereat in the area of Education Law with a focus on Contract and Liability in Tort, and Policy implementation since 2009, and in Company and Commercial Law since August 2013. He is an Examiner within the Department of Commercial Law at the University of Malta. He was admitted to the bar and holds a warrant conferred in January 2007 and has since then been actively involved in litigation within the Maltese Courts and Tribunals.

Mr Glen Bullivant

Fellow, Chartered Institute of Credit Management - Member of Executive Board and Advisory Council, Chairman of Technical Committee, member of Education Committee, Honorary Treasurer, and Vice President, CICM. Holder of a CICM Meritorious Service Award. Member of FECMA Council. Mr Joseph Farrugia

Mr Joseph Farrugia has occupied the post of Director General of the Malta Employers' Association since 2001. He is also a visiting lecturer at the Department of Marketing at the University of Malta.

Mr Farrugia has extensive experience in marketing consultancy and human resources management. Between 2010 and 2013 he served as President of the Malta College of Arts, Science and Technology, which is the major vocational education institution in Malta.

Mr. Farrugia sits on the board of directors of JobsPlus, the Employment Relations Board and represents the MEA on the Malta Council for Economic and Social Development. He also represents employers on panels of the Industrial Tribunal.

He has represented Maltese employers on a number of international fora, amongst them the Board of Directors of the European Foundation for the Improvement in Living and Working Conditions, the European Social Fund, SGI Europe and the International Organisation of Employers.

Mr Farrugia is known in cultural circles as an artist. He has organised numerous exhibitions of his paintings in various venues in Malta and abroad.



Elena Tabone

Elena Tabone, joined the FIAU in 2015 as a Compliance Officer. Throughout the years, she has been actively involved in the supervision of financial institutions and DNFBPs from an AML/CFT perspective. She has contributed extensively to the enhancement of the FIAU's supervisory framework, ensuring its continuous development in line with European and international requirements, as well as to cater more effectively for the ML/FT risks arising from the sectors falling within the FIAU's supervisory remit. Throughout her roles at the FIAU Ms Tabone was also responsible for the implementation of the Compliance and Supervision Platform for Assessing Risk System (CASPAR) and for risk assessing subject persons.



Ms Tabone currently heads the Enforcement Section of the FIAU. The Enforcement Section is responsible for the proper application of administrative measures imposed on subject persons by the FIAU's Compliance Monitoring Committee and for following up on remedial action plans presented by subject persons to ensure compliance with the AML/CFT legislative provisions

Ms Tabone obtained a Bachelor of Commerce (Hons) degree in Insurance and Finance from the University of Malta in 2014 and attained the CAMS qualification in 2020. Prior to joining the FIAU, she worked as a Commercial Claims Handler with a leading Maltese insurance broker.
